### **Local Firm WaveSource Inc. Secures Private Funding and Grant to Commercialize Cutting-edge Technology**

Local technology company WaveSource, Inc. continues their business development **securing \$600,000 in private equity funding** enabling them to move forward with their innovative eye exam technology and the production of custom multifocal contact lenses in Kalispell, MT. As they look to complete their second round of funding WaveSource Inc. continues to offer opportunities to potential private investors looking to invest in Montana technology and manufacturing businesses.

In addition to the private investment they received **\$87,633 in grant funding from the Montana Board of Research and Commercialization Technology. Research will be completed by Stephen Dunn, founder. Joining Stephen in this endeavor are David Israel, CEO; and Charles E. Campbell an expert in the field of wavefront optics.**

WaveSource, Inc. was formed in 2004 to commercialize its inventions related to the **design and manufacture of contact lenses which will correct many currently uncorrectable vision problems.** These inventions will provide a solution for millions of individuals who require vision correction. The company was awarded \$87,633 from the Montana Board of Research and Commercialization Technology (MBRCT) to develop the final technology to manufacture custom lenses designed to correct for high order aberrations and multifocal optics.

This research project and business endeavor offers an excellent opportunity in Montana to add precision-manufactured vision products as a new component to

the state's manufacturing base. The research will be conducted in partnership with MSU's Spectrum Laboratories which in turn, when completed, will lead to a collaborative relationship between WaveSource and Bridger Photonics.
